

Instruction Guide:

How to subscribe to ePermit Online Payment (EOP)

- 1. Firstly, you must be a subscriber to ePermit. No EOP registration is required.
- 2. Contact the bank personnel or approach the bank branch of your choice. You have an option either to use personal account or corporate account to make payment. Subscribe to bank's Online Banking & indicate the need to have the FPX payment module (for corporate account) in the application form. Upon registration, the bank will provide a training on how to use the system (via tele-con or face-to-face training).
